Cancer

In 2021, Woman's was named one of the World's Best Hospitals by Newsweek for our oncology care at the Breast & GYN Cancer Pavilion. World's Best rankings are determined by hospital recommendations from peers, patient experience surveys and medical outcome and quality metrics. The Pavilion provides comprehensive breast and gynecologic cancer care including surgery, treatment and survivorship support. **More than 87,000 patient cancer services were administered in 2021.**

Woman's received accreditation awards from the Commission on Cancer (CoC) and the National Accreditation Program for Breast Centers (NAPBC).

Imaging

Woman's launched an Interventional Radiology (IR) program that uses imaging technology to help guide minimally invasive surgical procedures such as mediports for infusion/chemotherapy and uterine fibroid embolization, and to treat life threatening conditions such as postpartum hemorrhages and blood clots. Since IR reduces cost, recovery time and risk associated with traditional open surgery, it is a growing option for many different procedures. **A total of 110 IR procedures were performed in the IR Suite in FY2021 and that number is expected to continue to grow.** IR services are provided in partnership with Radiology Associates.

The American Cancer Society Learning Collaborative provided Woman's with a \$20,000 grant to encourage women to return to annual mammograms.

Surgery

Despite several surges in COVID-19 cases, Woman's continued to grow its surgical volume, innovation and patient experience. The hospital was recognized with the Guardian of Excellence award for exceptional patient experience in its ambulatory (outpatient) surgery care. **Woman's also marked its highest surgical volume ever** with 8,666 cases in a single year.

Obstetrics

Nursing recruitment and retention was a major focus for Woman's and the entire healthcare industry. Despite a competitive market, the hospital's largest departments - Labor and Delivery, Mother/Baby, and NICU - continued to work toward improving women and infant's health. These departments play a major role in LaPQC, a statewide perinatal collaborative, and numerous research studies aimed at improving perinatal care. **Woman's also launched a safe sleep media campaign for newborns with a grant from the LA Children's Trust Fund.**

At the Louisiana State Nurses Association annual Nightingale Awards, Monica Frederic, RN, was named Mentor of the Year.

NICU

Furthering our expertise in caring for the most fragile infants, **we continued to work treating chronic lung disease, the most common reason for morbidity and mortality in micro-premature babies,** babies weighing less than 750 grams or born before 26 weeks. Woman's also partnered with the internationally recognized Vermont Oxford Network (VON) to improve infant outcomes, expanded our family experience with a parent partner to help guide families throughout the pandemic, and began staff resilience activities including comfort care carts.

Christina Bell, BSN, RN, Darla Mathews, MSN, RNC-NIC, and Stephanie Powers, BSN, RNC-NIC, were recognized by the March of Dimes for Excellence in NICU Nursing in Louisiana.


Medical

With an increased focus on specialized women's health and wellness, Woman's strategically expanded several service lines. **The addition of two new gynecologic oncologists enabled us to expand cancer care into the Lafayette and Hammond markets.**

Woman's developed a comprehensive weight management program to customize the approach to successful weight loss from lifestyle changes to medically driven solutions including weight loss surgery. **Our weight loss navigator helped more than 1,200 individuals.**

Diversity & Inclusion

Woman's made a strong commitment to improving diversity and inclusiveness for our patients, families and our community. This important, long-term initiative began with education; engaging and asking our leaders to serve as ambassadors for change and hospital wide unconscious bias classes. An Inclusive **Excellence Action Committee (IEAC) was** organized and began the path toward embracing all ethnicities, lifestyles and **identities.** Additional staffing began the work to decrease racial disparities in breastfeeding. We identified and enhanced care for transgender patients and revised registration information to capture race, ethnicity, preferred name and personal pronouns.
